



Prospectus for JURIED Artwork Canterbury Art Show... *A Tapestry of the Arts*

September 4 - September 7, 2020

We are pleased to present this JURIED Artwork Prospectus in the Call to Artists for participation in the 2020 **Canterbury Art Show... *A Tapestry of the Arts***, a premier local exhibition and sale of artwork at St. George's-by-the-River in Rumson, NJ.

This 3-day event will be actively marketed and promoted via the Internet, through social and print media to New Jersey's art community, and through our parish of over 400 members.

This prospectus applies specifically to the JURIED portion of this event. The artwork submitted herein must be original artwork and not have been submitted in this show in prior years. Awards will be presented to the Juried Gallery winners at the *Meet the Artists Reception*, on Friday, September 4, 2020. First prize is "Best in Show". Second prize is the Award of Excellence and Honorable Mention goes to the top scores in each medium category.

Proceeds from the Canterbury Art Show will directly benefit St. George's-by-the-River Episcopal Church and its many Outreach programs. We are proud of the impactful Outreach programs that serve our community. St. George's awards annual grants to over 30 local agencies including Lunch Break, Family Promise, HABcore, 180 Turning Lives Around, and Love Thy Neighbor, just to name a few.

Some basic information:

- Only those artists who submit an Artist Participation Form and required entry fee(s), no later than the deadline of midnight May 10, 2020 will be considered to be included in the Canterbury Art Show. The Artist Participation Form can be found at www.canterburyartshow.com
- All artwork must be priced with the true intention of selling the artwork.
- The Canterbury Art Show (St. George's-by-the-River) will retain a 30% commission on all artwork sold.
- Any artist who is 18 years of age or older is eligible to participate. There are separate segments of the show for non-juried artwork. (See separate prospectus for complete information.)
- No artwork will be accepted without prior registration and an inventory list of submitted artwork.
- The Canterbury Art Show reserves the right to use digital images of accepted and exhibited artwork for the purpose of media, website, public relations and advertising.
- Participating artists will be our guests at the *Meet the Artists Reception* on Friday, September 4th.
- The Canterbury Art Show is open to the public Saturday, Sunday & Monday of Labor Day Weekend for an admission fee of \$10.

Juried Artwork Exhibit and Sale Requirements

Artwork is accepted in the following mediums: Watercolor, Oil, Pastel, Acrylic, Mixed Media, Drawing, Graphic, Photography, Digital Photography, Etching, Lithograph, Silk-Screen, Stone-Block, and Rubbings. Off-set, computer art and crafts are not eligible.

Only those artists who submit an Artist Participation Form and entry fee(s) no later than the **May 10, 2020** midnight deadline will be considered part of the Canterbury Art Show.

Specific Requirements for JURIED Submissions

- Entries must be framed or on canvas that wraps around the sides of the piece with no staples visible. All pieces must be wired for hanging. Tab hangers are not acceptable.
- All Juried artwork must be original and cannot have been entered in this show in prior years.
- Size should not exceed 864 square inches or 24 x 36, including the frame.
- Minimum pricing for all Juried artwork is \$400. There is no maximum price.
- A limit of 3 pieces of artwork may be submitted for the jurors review (new and not previously submitted.)
- The Juried Gallery will be limited to 60 pieces of artwork based on juror's scoring.
- The jury reserves the option to select all, some, or none of the submitted artwork.
- The non-refundable entry fee is \$50*.

***If you choose to enter any 3 categories of the art show –**

Juried, Non-Juried Original, Non-Juried Unframed, Non-Juried Dimensional or Non-Juried Large Art, the discounted fee for 3 categories is \$125.

Juried Gallery Artwork Submissions

Juried Gallery Artwork Submission Form and Inventory List may be submitted along with the Artist Participation Form or submitted separately later. However, **the juried artwork submission form and inventory list (including jpg format files) must be received no later than midnight June 14, 2020.** Each accepted piece must be available for exhibition and sale during the entire show and remain at St. George’s-by-the-River throughout the show. There are two ways to submit your artwork to the jury:

1. **Submit Form/Artwork Images Online:** Complete the Juried Gallery Artwork Submission Form and Inventory List for up to 3 pieces of artwork. List your artwork and upload an image of each piece in 72 to 300 dpi jpg format.
2. **Submit Form/Artwork Images by Mail:** Complete and mail the Juried Gallery Artwork Submission Form and Inventory List for up to 3 pieces of artwork. List your artwork and create a CD with an image of each piece in 72 to 300 dpi jpg format. Clearly label the CD with your name and the titles of your artworks. Your CD will not be returned. Sunday, June 14, 2020 Midnight	Deadline to submit the Juried Gallery Artwork Submission Form and artwork digital images
Sunday, June 28, 2020 Midnight	Deadline to submit the Art-by-Teens Participation Form
Week of July 19, 2020	All Juried Artists will be notified of accepted pieces, based on Jury results, by the end of the week
Sunday, August 9, 2020 Midnight	Deadline for receipt of Submission Forms for artwork in all Non-Juried segments – Original Art, Non-Framed Art, Dimensional Art, and Large Art and digital images. Art-by-Teen Submission form deadline.
Sunday, August 16, 2020	Deadline for receipt of Participation Forms for Art from Artists and Artists-at-Work. Notification of accepted Non-Juried pieces.
Sunday, August 30, 2020 12pm – 4pm	Artist drop-off for all artwork
Monday, August 31, 2020 10am – 4pm	Artist drop-off for all artwork
